MESSAGE FROM THE HEAD OF UNIT



As stated by H.E the President, Gen Yoweri Kaguta Museveni, in his various speeches to the nation, corruption remains a key obstacle to Uganda's development.

In this regard, the NRM government has enacted a number of laws, regulations and put policies to fight the vice, in addition, since 1986, various institutions have been established to counter corruption and deal with its perpetrators. It is in light of this that in December 2018, H.E the President established the State House Anti-Corruption Unit (SH-ACU).

The Unit is agile and swift in its response to complaints by the general public on cases of corruption in the country. In the execution of its mandate, SHACU coordinates closely with a number of stakeholders, particularly the Police, IGG,

Office of the Auditor General, the PPDA, ISO, UPDF, the office of the Minister for the Presidency, among others.

Together, a lot has been achieved, including recovering and saving loss of Government funds amounting to 35.484 billion Uganda shillings, arresting and arraigning in Courts of law 448 suspects, out of which, 70 have been convicted.

Finally, I take this opportunity to thank you all, the Wanainchi, the media, religious leaders and all stakeholders who continue working with us in fighting corruption in the country. No doubt, the war on corruption is winnable.

MANDATE

SHACU derives its mandate from article 99(4) of the Constitution of Uganda (1995) as amended, which provides that “functions conferred upon the President may be exercised by the President either directly or through officers subordinate to the President.” The President, therefore, established SHACU to receive, scrutinize, and coordinate speedy processing of corruption complaints.

VISION

A Corruption Free Uganda.

MISSION

To be the catalyst and accelerator of the anti-corruption fight through receiving, scrutinizing and coordinating a speedy processing of corruption complaints by constitutionally mandated agencies.

STRATEGIC DIRECTION

SHACU continues to address key initiatives that strengthen coordination and collaboration of anticorruption agencies, building trust with the public and delivering speedy resolution of citizens' complaints. This is demonstrated in our **four strategic focus areas** which are:

Prevention Strategy:

This focuses on crippling corruption by facilitating interventions that stop acts of corruption.

Detection and Disruption:

Corruption is dynamic in nature, the Unit has adapted innovative ways to disrupt high profile corruption and grand schemes usually at the inception stage. Working with other agencies like ISO the unit has focused on the ability to tell the occurrence of acts or omissions of corruption. This has facilitated anonymous reporting by the citizens through a wide range of platforms, and liaison and information sharing with other government agencies.



March 04th, 2022: Drugs retrieved and recovered through detection and disruption being delivered back to Joint Medical Stores offices.

With our disruption and detection strategy, we have intervened and prevented fraudulent disposal of government lands including:

- a. Along River Mpanga Mill lane in Fort Portal City
- b. Lira city land
- c. Land belonging to Kazo Primary School, in Kawempe (Half acre)
- d. Land in Kyarwabuganda, Mbarara district (7 acres)
- e. Kaduku Forest Reserve Land, Masindi

Support and co-ordination:

SHACU has collaborated and coordinated with government agencies statutorily mandated to fight corruption through nurturing linkages with them for collaborative investigation to enable speedy resolutions of cases.
